The Board of Directors of Kranti Industries Limited (hereinafter referred to as "The Company") at its meeting held on Saturday 27rd May 2023 has appointed me as the Scrutinizer for the Postal Ballot process conducted pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules 2014, Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

RESULT

Since the promoters (Smt Indubala Vora, Mr Sachin Vora and Mr Sumit Vora) are interested in the agenda/resolution, the votes of Interested Promoters / Directors are not counted for the results. Votes cast by promoters / directors for the resolution is 5830313, which amount to 75.51 % of total votes casted in E voting.

As the number of vote cast in favour of the resolution are more than three times the number of votes cast by shareholders against the resolution, based on the aforesaid result, I report that the Special resolution as set out in Item No 1 of the Notice of the Postal Ballot has been passed with requisite majority.

All the resolutions mentioned in the Notice of Postal Ballot dated 30th May 2023 as per the results above stand passed under remote e-voting with the requisite majority and deemed to be passed.
