Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"), we wish to inform you that Kranti Industries Limited ("the Company") has received a notice from the State Bank of India ("SBI") under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 ("SARFAESI Act").

The notice pertains to a Corporate Guarantee provided by the Company in respect of the credit facilities availed by Preciso Metall Private Limited, an Associate Company of the Company.

The Company is currently reviewing the contents of the notice and evaluating the appropriate course of action, including the legal remedies available to it. The Company will keep the Stock Exchange informed of any further material developments in this regard.
